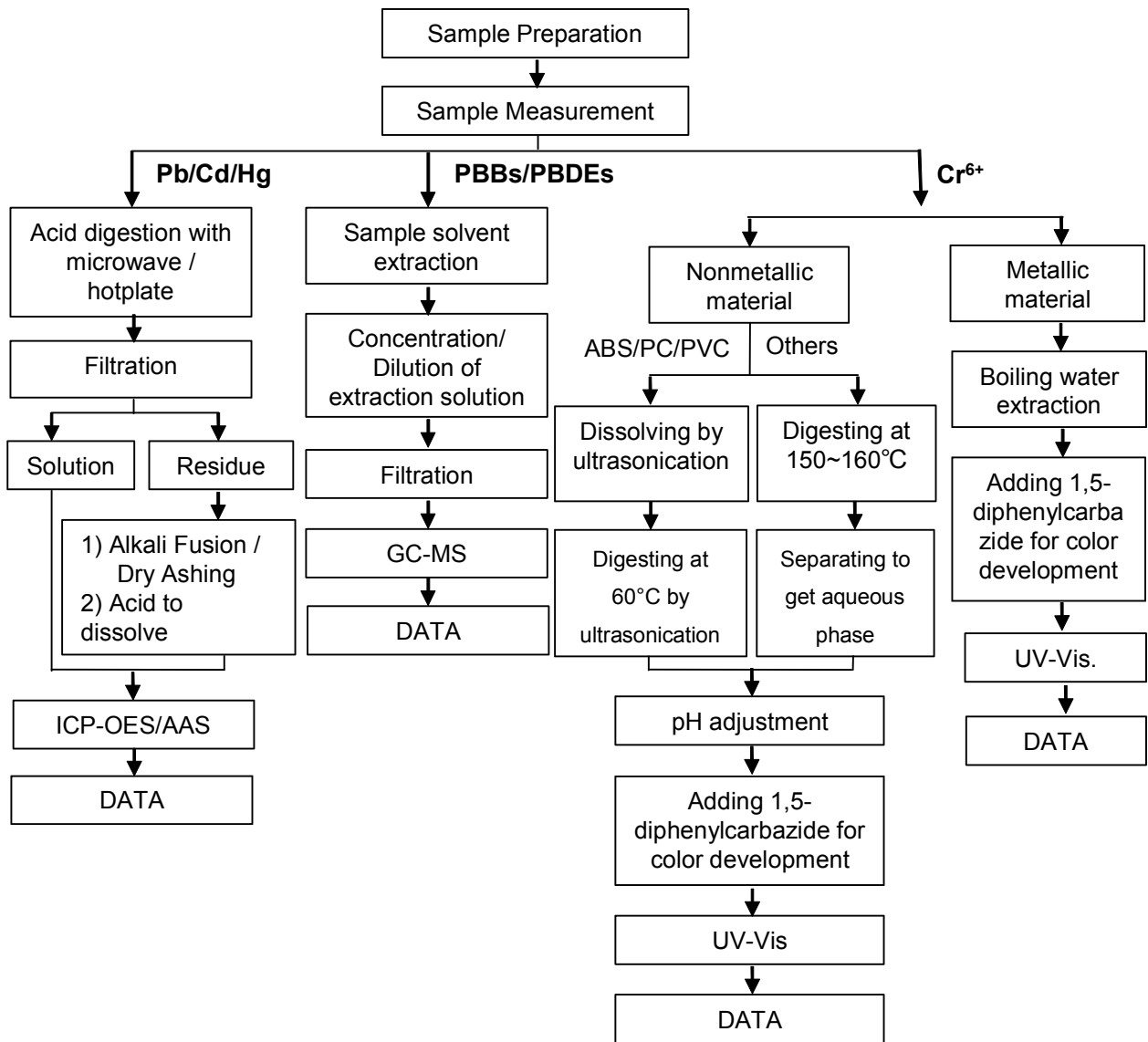

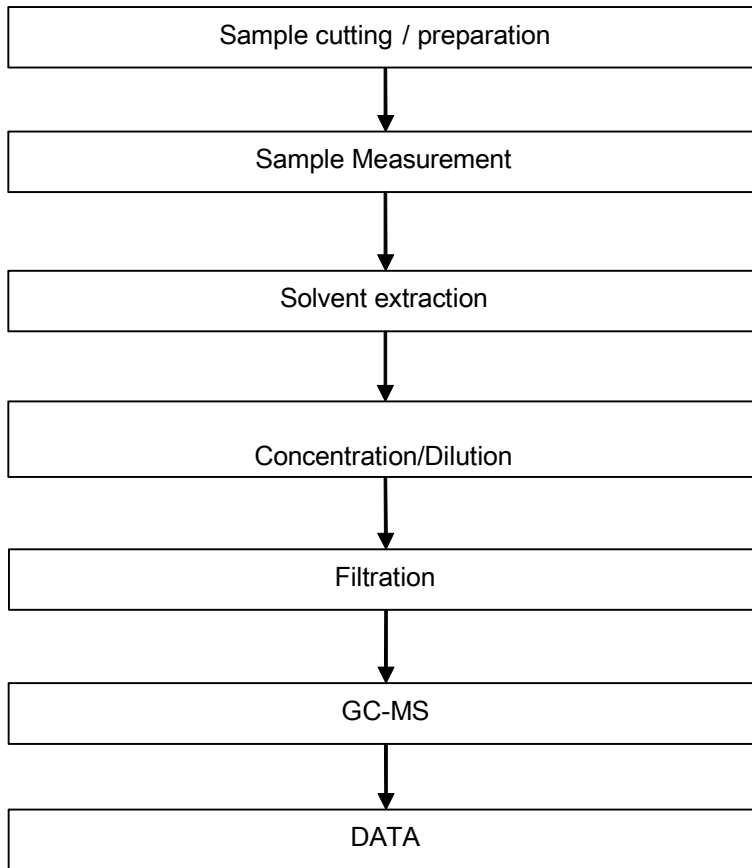

Phthalates Testing Flow Chart



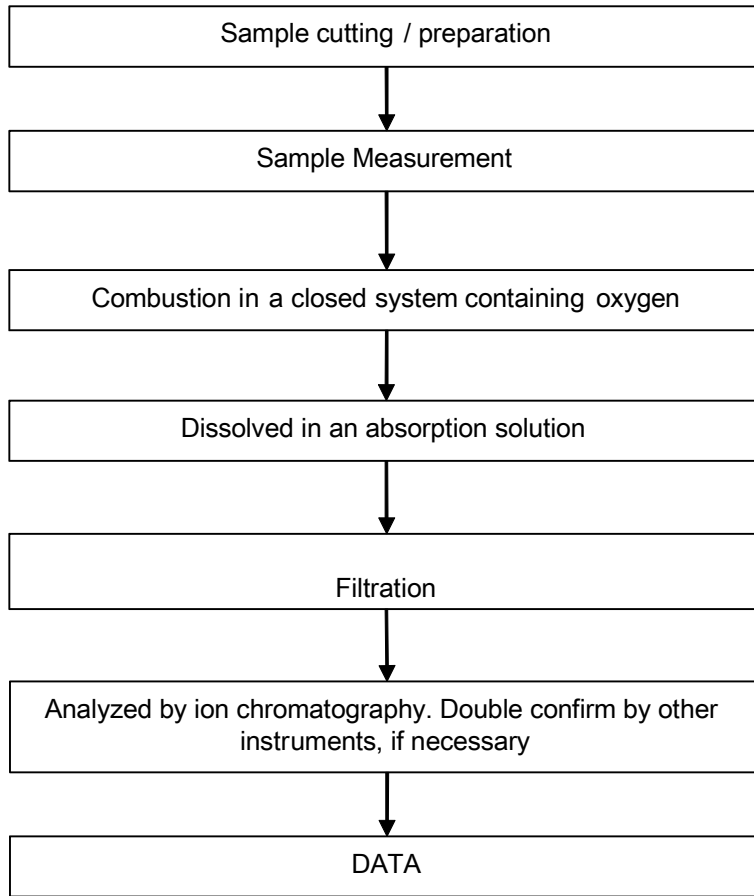

Halogen Testing Flow Chart

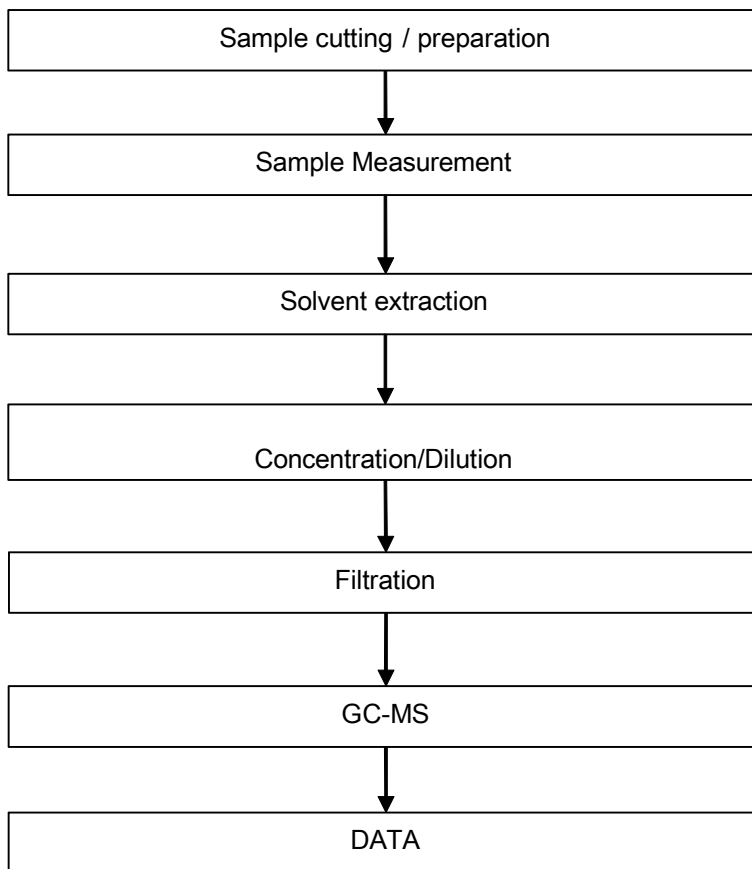

### PAHs Testing Flow Chart

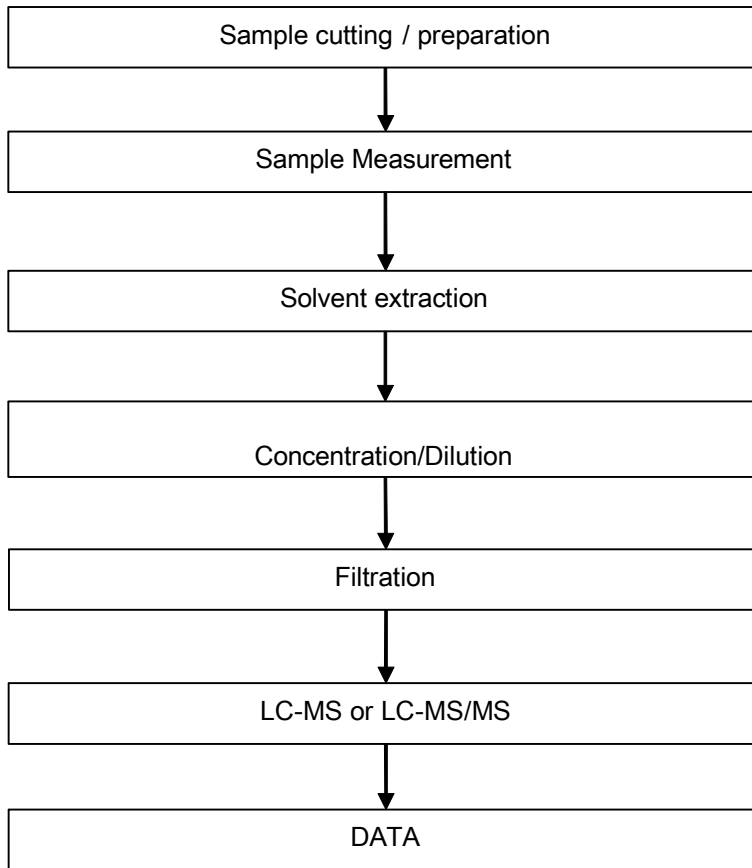
