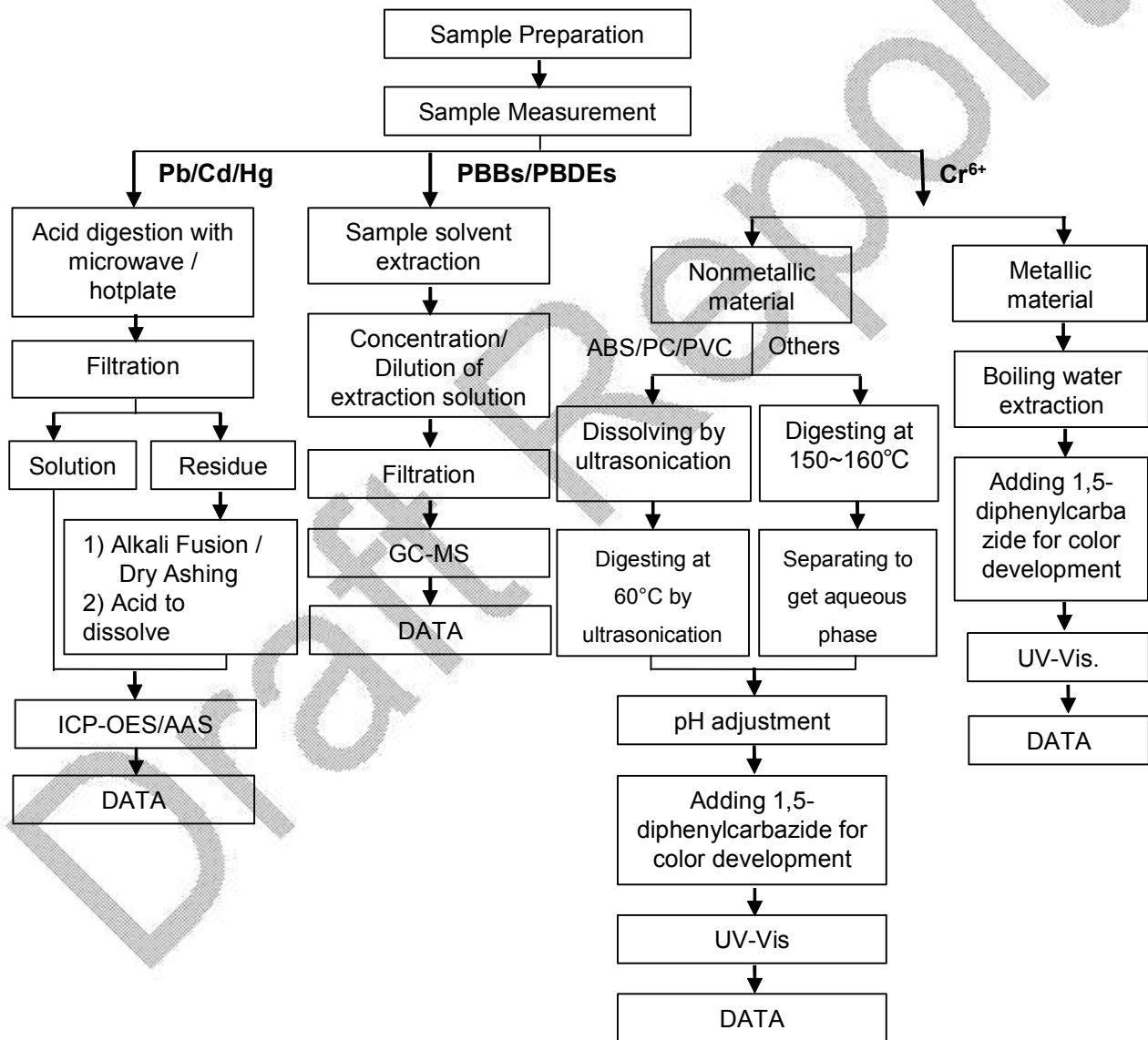

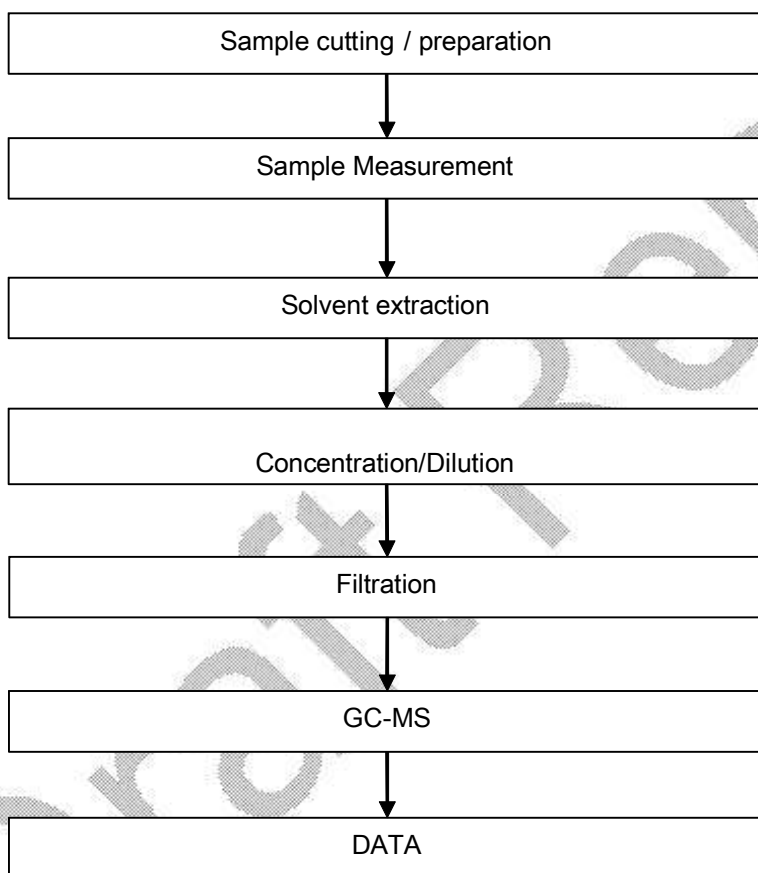

Phthalates Testing Flow Chart



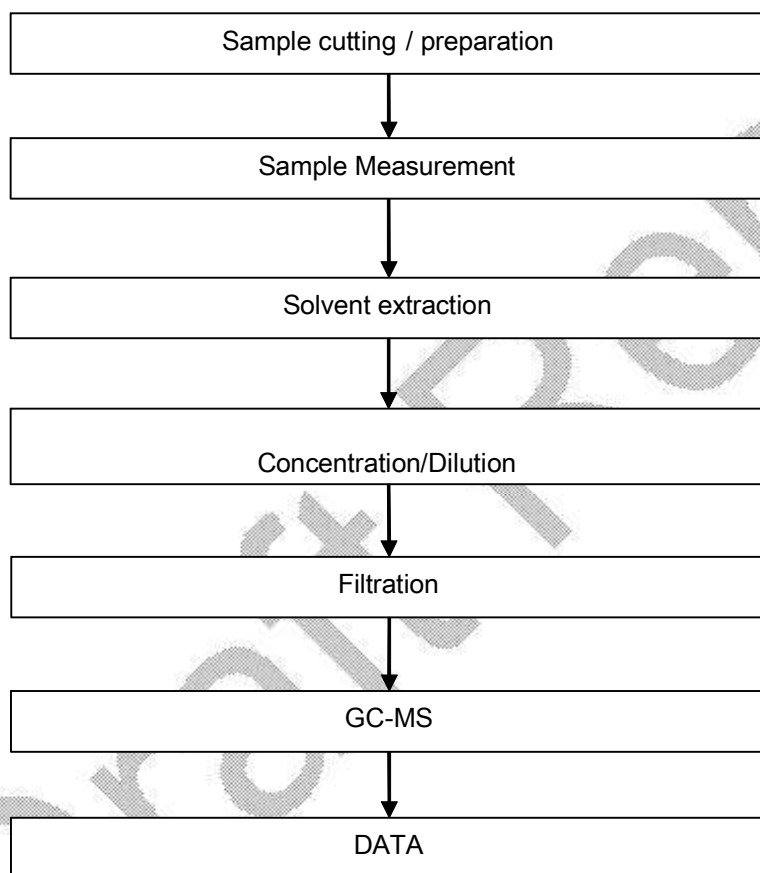

PAHs Testing Flow Chart

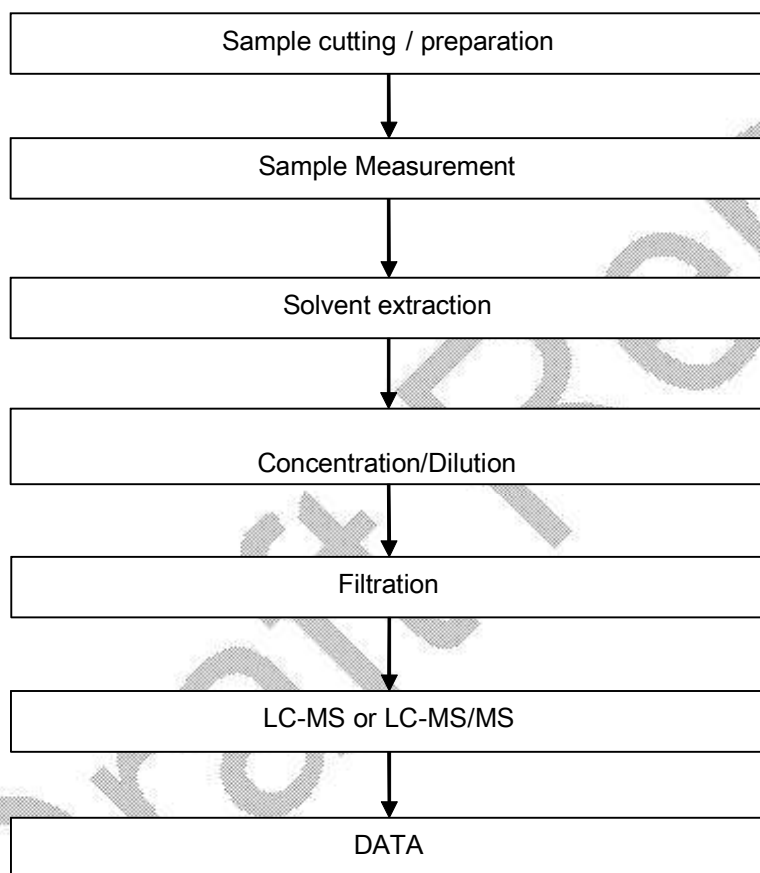
